The club is currently selling advertising spaces for the 2011 "Fireworks Promotional Banners", which for the last two years was able to recognize nine local businesses and raise almost \$5,000. The banners will be placed on Main Street, as well as at the Boulder County Fairgrounds for the week prior to the holiday.
